



# FARMHOUSE FOUNDATION SCHOLARSHIPS

---

*Each year, the FarmHouse Foundation awards scholarships on the basis of academic achievement, exemplary integrity, ethics, initiative and industry conducive to ongoing leadership, career potential and service to others.*

## Eligibility

Scholarships are open for all FarmHouse chapter members to apply, several are also open to graduate students and the Grover and Lloyd Scholarships are also open to female legacies of FarmHouse members. Recipients must maintain the foregoing criteria for the academic year for which it is awarded in order to receive the full scholarship. Scholarships are renewable contingent on re-application, but not normally renewable for more than four successive years.

## Application Deadline

Scholarship applications and letters of support must be sent to the FarmHouse Foundation bearing a postmark no later than **June 1, 2024**. Every effort will be made to notify the recipient well in advance of the fall semester, particularly if the recipient demonstrates a need that might prevent his continued enrollment.

## Scoring

Selection of recipients will be made by a committee appointed by the FarmHouse Foundation Trustees. An ideal applicant should have a commitment to achieve the level of values that FarmHouse holds so dear, in particular those principles of leadership, scholarship and a genuine interest in the success of their brothers. Applicants will be scored on their scholarship record (30 points); evidence of high moral character, integrity and ethics (25 points); leadership and service (25 points); and letters of support (20 points).

# SCHOLARSHIPS & REQUIREMENTS

## THE ACKER/FOLKEN SCHOLARSHIP

*One \$900 scholarship will be awarded to a member of FarmHouse Fraternity for the 2024-25 academic year as a result of the generosity of Duane (IA 49) and Shirley Acker as well as the late Herbert G. Folken (IA 28).*

The recipient must be an initiated member of FarmHouse Fraternity, enrolled at a university hosting a FarmHouse chapter, carrying a schedule typical for their classification, living in the chapter house if an undergraduate and space is available, or in the city where the university is located if a graduate student. The recipient will be selected on the basis of academic achievement, exemplary integrity, ethics, initiative and industry conducive to ongoing leadership, career potential and service to others. The recipient must have a grade point average above or equal to the chapter's average, and shall maintain satisfactory behavior. In the event two or more of the scholarship candidates are considered to be of equal merit, preference shall be given to (1) the candidate demonstrating the most need, particularly if that need might prevent the student's continued enrollment; and/or (2) members of the chapters at Iowa State University, South Dakota State University, Kansas State University, Oklahoma State University and the University of Nebraska.

## ❑ THE FICHTER FAMILY SCHOLARSHIP FUND

*One \$5,000 scholarship will be awarded to a member of FarmHouse Fraternity for the 2024-25 academic year in memory of the late A. Corby Fichter, Jr. (IA 50) by the Fichter family.*

The recipient must be an initiated member of FarmHouse Fraternity, enrolled at a university hosting a FarmHouse chapter, carrying a schedule typical for their classification, living in the chapter house if an undergraduate and space is available, shall have a grade point average of a 2.75 or better, and maintain satisfactory behavior. The recipient will be selected based on demonstration of how FarmHouse has positively impacted his life, exhibited significant growth in character, made sacrifices through participation in the brotherhood of FarmHouse Fraternity and achieved his personal academic goals. In the event two or more of the scholarship candidates are considered to be of equal merit, preference shall be given to (1) the candidate demonstrating the most need, particularly if that need might prevent the student's continued enrollment; and/or (2) a candidate who is also a student member of the Iowa State FH Chapter.

## ❑ THE WAYNE & VIRGINIA GROVER FAMILY SCHOLARSHIP

*One \$1,000 scholarship will be awarded to an individual, majoring in veterinary medicine, agriculture and/or life sciences, for the 2024-25 academic year as a result of the generosity of Wayne (KS 59) and Virginia Grover.*

The recipient must be an initiated member of FarmHouse Fraternity or may be a female legacy of a FarmHouse member (i.e. daughter, granddaughter, sister or niece), enrolled at a university hosting a FarmHouse chapter. Alumni members in graduate school may also apply if enrolled at a university hosting a FarmHouse chapter. The recipient must be majoring in veterinary medicine, agriculture, and/or life sciences and carrying a schedule typical for their classification. The recipient will be selected based on academic achievement, exemplary integrity, ethics, initiative and industry conducive to ongoing leadership, career potential and service to others. The recipient must have a grade point average above or equal to the chapter's average and shall maintain satisfactory behavior. In the event two or more of the scholarship candidates are considered to be of equal merit, preference shall be given to the candidate demonstrating the most need. The scholarship may be renewable, but must be re-applied for each year, and not normally renewable for more than three successive years. A preference will be given to a prior scholarship recipient.

## ❑ THE LARRY HERMAN HAGEMAN CROP SCIENCES SCHOLARSHIP

*One \$1,600 scholarship will be awarded to a member of FarmHouse Fraternity, majoring in crop sciences, horticulture, soil sciences, plant pathology or entomology, for the 2024-25 academic year as a result of the generosity of Larry H. Hageman (OH 94).*

The recipient must be an initiated member of FarmHouse Fraternity and enrolled at a university hosting a FarmHouse chapter. The recipient must be majoring in crop sciences, horticulture, soil sciences, plant pathology or entomology and carrying a schedule typical for their classification. The recipient shall live in the chapter house if space is available, shall have a grade point average of a 2.5 or better, and shall maintain satisfactory behavior. If there is no candidate enrolled in these majors who qualifies, the scholarship can be awarded to a student member majoring in agriculture. The recipient will be selected on the basis of academic achievement, exemplary integrity, ethics, initiative and industry conducive to ongoing leadership, career potential and service to others. In the event two or more of the scholarship candidates are considered to be of equal merit, preference shall be given to the candidate demonstrating the most need. The scholarship may be renewable, but must be re-applied for each year, and not normally renewable for more than four years.

## ❑ THE BERT KRANTZ MEMORIAL SCHOLARSHIP

*One \$1,300 scholarship will be awarded to a member of FarmHouse Fraternity, majoring in agriculture, for the 2024-25 academic year as a result of the generosity of the late Bert (MI 36) and Nell Krantz.*

The recipient must be an initiated member of FarmHouse Fraternity, enrolled at a university hosting a FarmHouse chapter, carrying a schedule typical for their classification, living in the chapter house if an undergraduate and space is available, or in the city where the university is located if a graduate student. The recipient must be seeking a degree in agriculture. The recipient will be selected on the basis of academic achievement, exemplary integrity, ethics, initiative and industry conducive to ongoing leadership, career potential and service to others. The recipient must have a grade point average above or equal to the chapter's average, and shall maintain satisfactory behavior. In the event two or more of the scholarship candidates are considered to be of equal merit, preference shall be given to the candidate demonstrating the most need.

## ❑ THE CHRIS H. & VICKI LEMBCKE SCHOLARSHIP FUND

*Three \$2,000 scholarships will be awarded to members of FarmHouse Fraternity for the 2024-25 academic year as a result of the generosity of the late Chris (CO 67) and Vicki Lembcke.*

Recipients must be initiated members of FarmHouse Fraternity, enrolled at a university hosting a FarmHouse chapter, carrying a schedule typical for their classification, living in the chapter house if an undergraduate and space is available. Recipients must have a grade point average above or equal to the chapter's average, and shall maintain satisfactory behavior. The exhibit of financial need, particularly if the recipient demonstrates need might prevent his continued enrollment, will be a minor consideration.

## ❑ THE W. EUGENE & LINDA LLOYD SCHOLARSHIPS

*Four \$3,100 scholarships will be awarded to individuals, majoring in agriculture and/or life sciences, for the 2024-25 academic year as a result of the generosity of the late W. Eugene (IA 47) and his widow, Linda Lloyd.*

Recipients must be initiated members of FarmHouse Fraternity or may be a female legacy of a FarmHouse member (i.e. daughter, granddaughter, sister or niece), enrolled at a university hosting a FarmHouse chapter. Alumni members in graduate school may also apply if enrolled at a university hosting a FarmHouse chapter. Recipients must be majoring in agriculture and/or life sciences and carrying a schedule typical for their classification. Recipients will be selected on the basis of academic achievement, exemplary integrity, ethics, initiative and industry conducive to ongoing leadership, career potential and service to others. Recipients must have a grade point average above or equal to the International Fraternity's average, and shall maintain satisfactory behavior. In the event two or more of the scholarship candidates are considered to be of equal merit, preference shall be given to the candidate demonstrating the most need.

## ❑ THE ROBERT A. LONGENBAUGH SCHOLARSHIPS

*Two \$2,700 scholarships will be awarded to members of FarmHouse Fraternity, majoring in water, environmental or civil engineering, agronomy, hydrology or water-related degrees, for the 2024-25 academic year as a result of the generosity of the late Bob Longenbaugh (CO 54).*

Recipients must be initiated members of FarmHouse Fraternity and enrolled at a university hosting a FarmHouse chapter. Recipients must be majoring in or receiving an advanced degree in water, environmental or civil engineering, agronomy, hydrology or water-related degrees. Recipients shall live in the chapter house if an undergraduate and space is available, or in the city where the university is located if a graduate student. They must carry a cumulative grade point average above or equal to the International Fraternity's average and

shall maintain satisfactory behavior. Recipients will be selected on the basis of having exhibited significant growth in character, academic achievement, exemplary integrity, ethics, initiative and industry conducive ongoing leadership, career potential and service to others. In the event two or more of the scholarship candidates are considered to be of equal merit, preference shall be given to a member of the Colorado State FarmHouse chapter. The scholarships may be renewable, but must be re-applied for each year, and not normally renewable for more than four successive years.

### **❑ THE WILLIAM S. & CATHERINE MAY SCHOLARSHIPS**

*Five \$1,600 scholarships will be awarded to members of FarmHouse Fraternity for the 2024-25 academic year as a result of the generosity of the late William (OK 38) and Catherine May.*

Recipients must be initiated members of FarmHouse Fraternity, enrolled at a university hosting a FarmHouse chapter, carrying a schedule typical for their classification, living in the chapter house if an undergraduate and space is available, or in the city where the university is located if a graduate student. Recipients will be selected on the basis of academic achievement, exemplary integrity, ethics, initiative and industry conducive to ongoing leadership, career potential and service to others. Recipients must have a grade point average above or equal to the chapter's average, and shall maintain satisfactory behavior.

### **❑ THE DOUGLAS D. & NANCY J. SIMS SCHOLARSHIPS**

*Two \$2,500 scholarships will be awarded to outstanding student leaders of FarmHouse International Fraternity who exemplify the FarmHouse Object and are considered to be builders of men for the 2024-25 academic year as a result of the generosity of the late Doug Sims (IL 65) and his widow, Nancy Sims.*

Recipients must be initiated and involved members of FarmHouse Fraternity, enrolled at a university hosting a FarmHouse chapter, live in the chapter house if space is available and maintain satisfactory behavior.

Recipients must carry a schedule typical for their classification and have a cumulative grade point average above or equal to the International Fraternity's average for the preceding 12 months. Recipients will be selected on the basis of academic achievement, exemplary integrity, ethics, initiative and industry conducive to ongoing leadership, career potential and service to others. In the event two or more of the scholarship candidates are considered to be of equal merit, preference shall be given to the candidate(s) demonstrating the most financial need. The scholarships may be renewable, but must be re-applied for each year, and not normally renewable for more than three successive years.

### **❑ THE DANNY WEISZ MEMORIAL SCHOLARSHIP**

*One \$2,200 scholarship will be awarded to a member of FarmHouse Fraternity for the 2024-25 academic year, in memory of the late Danny Weisz (ID 89).*

The recipient must be an initiated member of FarmHouse Fraternity, have 30 credits minimum completed at the end of the semester of application, shall have a grade point average of a 2.7 or better. The recipient will have lived in the chapter house for two semesters including the semester during which the award is to be used and maintain satisfactory behavior and progress in the brotherhood of FarmHouse Fraternity. The exhibit of financial need, particularly if the recipient demonstrates need might prevent his continued enrollment, will be a minor consideration.

## ❑ THE CLAYTON K. YEUTTER SCHOLARSHIP

*HONORING HIS SERVICE AS UNITED STATES SECRETARY OF AGRICULTURE, 1989 TO 1991*

*One \$2,700 scholarship will be awarded to a member of FarmHouse Fraternity, majoring in agriculture and/or public affairs for the 2024-25 academic year, in memory of the late Clayton Yeutter (NE 49).*

The recipient must be an initiated member of FarmHouse Fraternity and enrolled at a university hosting a FarmHouse chapter. The recipient must be majoring in agriculture and/or public affairs and carrying a schedule typical for their classification. They must have a grade point average above or equal to the Fraternity's average; and shall have been recognized for their contributions to the Fraternity, their home or university community, and/or organizations related to agriculture. The recipient will be selected on the basis of academic achievement, exemplary integrity, ethics, good moral character, initiative and industry conducive to ongoing leadership, career potential and service to others. In the event two or more of the scholarship candidates are considered to be of equal merit, preference shall be given to a member of the Nebraska FarmHouse Chapter. The scholarships may be renewable, but must be re-applied for each year, and not normally renewable for more than four successive years.
